#### **BACKGROUND**

- The Authority has a series of committees to which appointments are made at the first or annual meeting. These are set out below.
- The Authority in the past has determined not to apply political balance to the membership of its Committees under regulation 20 of the Local Government (Committees and Political Groups) Regulations 1990. This issue was revisited during the constitutional review in mid 2008-09. There has been a prevailing consensus that political balance would not be beneficial as the current arrangements are both inclusive and avoid creating any 'political division' in the governance of an Authority.

- 7 Appointments are to be made to the following Committees:-

  - Audit Committee (14 members)
  - Standards Committee (2 members) (not required to be politically balanced under the Standards Committee (Wales) Regulations 2001) (see separate report on the agenda).
- 8 The terms of reference of the above committees are included in the Constitution.
- Given that the constituent authorities are required to apply the principle of political balance to their committees (other than in the case of cabinets), authorities are encouraged to nominate members to this Authority on the basis of political balance. The Authority itself should consider annually whether it wishes to apply political balance noting the comments in 3 above. Should the Authority apply this principle, appointments to committees should be made which ensure that the constituent authorities all have sufficient representation.
- The membership of the Executive Panel consists of 14 members and comprises the Chair and Deputy Chair of the Authority and two members per constituent authority. This membership represents 50% of the Authority's membership. The role and membership of the Panel was expanded in the constitutional review in mid 2008-09.

The Authority agreed to introduce an Audit Committee to review, 11 scrutinise and assure, independently of the Executive, the operational and financial performance of the organisation. The membership of the Committee is the remaining 50% of the membership who are not appointed to the Executive Panel.

# **BACKGROUND**

- 4 Under the Local Government Act 2000, the Fire and Rescue Authority is required to have a Standards Committee. There are four independent members on the committee.
- Any member of the Fire and Rescue Authority, apart from the Chair and Deputy Chair, can be appointed to serve on the Standards Committee.
- 6 Under the Standards Committee (Wales) Regulations 2001, the political balance requirements of Part I of the Local Government and Housing Act 1989 do not apply to these appointments.

# **ADVICE**

Any members apart from the Chair and Deputy Chair of the Authority are eligible for appointment to the Committee.

- Whichever members are selected should be appointed to serve until the next ordinary local elections in May 2027. The terms of office of members of the Standards Committee would then expire as follows:
  - 2 independent members second term expires in December 2025
  - 2 independent members first term expires August 2023
  - 2 Fire Authority members May 2027 (dependent on who is appointed, one or both could be eligible for reappointment for a further term).

# **PURPOSE OF REPORT**

To appoint four Fire and Rescue Authority members to serve on the Firefighters' Pension Scheme Local Pension Board.

#### **EXECUTIVE SUMMARY**

To appoint four Fire and Rescue Authority members to serve on the Firefighters' Pension Scheme Local Pension Board.

#### **RECOMMENDATION**

- 3 Members are asked to:
  - (i) note the information in the report;
  - (ii) nominate four representatives on the local pension board.

# **BACKGROUND**

The Local Pension Board was established in 2015 following the introduction of the Public Service Pensions Act 2013 in relation to the Firefighters' Pension Schemes. The board has to include employer and employee representatives in equal numbers. As a consequence North Wales Fire and Rescue Authority will be required to nominate four members to sit on this board.

#### **INFORMATION**

The Public Service Pension Act 2013 provides for clearer governance arrangements with specific defined roles, the publication of more information on a consistent basis, and administration practices in line with those in the private sector.

- 6 Local Pension Boards are charged with helping the scheme manager (Fire and Rescue Authority) to ensure that the scheme is operated to an appropriate standard and, in particular, will:
  - ensure that pension schemes are administered in accordance with all relevant legislation and any directions given to the scheme by the Pensions Regulator
  - assist the scheme manager (Fire and Rescue Authority) in securing the effective and efficient administration of the pension scheme
  - have appropriate knowledge about the scheme they are helping to run
  - ensure that information is available to scheme members and other interested parties so that they can easily see and understand who is a pension board member, how pension scheme members are represented on the pension board and the responsibilities of the pension board
  - prevent a person from being a member of a pension board where they have another interest that could prejudice them carrying out the role.
- The scheme manager (Fire and Rescue Authority) is responsible for appointing members of the pension board. The scheme manager must ensure that no conflict of interest exists at the time of a member's appointment, and while the member continues to serve. Conflict of interest is defined as a financial or other interest which is likely to prejudice a person's exercise of functions as a member of a pension board.
- The Firefighters' Pension Schemes are accounted for in the NWFRA accounts as it is ultimately funded by Welsh Government (WG) in accordance with the relevant legislation. The Treasurer is responsible for certifying the claims to WG and they are audited each year by the external auditors. It would also be appropriate that the Monitoring Officer and Treasurer should have the right to attend or be represented at the local pension board meetings.

# **Member Requirements**

A member of a public service pension board must be conversant with the rules of the scheme and any document recording policy about the administration of the scheme. As this is a board (rather than a committee) the Authority can appoint officers as well as councillors as the employer representative. Historically the clerk and treasurer have served as employer representatives.

- 10 A member must have knowledge and understanding of the law relating to pensions and any other matters which are prescribed in regulation.
- 11 An e-learning programme is provided by the Regulator to meet the needs of all pension board members.

# **OBSERVATIONS FROM THE EXECUTIVE PANEL/AUDIT COMMITTEE**

4 This report has not previously been considered by Members.

# **BACKGROUND**

The remit of the Independent Remuneration Panel (IRP) was extended through the Local Government (Wales) Measure 2011. Under the powers provided by the Measure, the IRP has produced a new set of Regulations which came into effect on 1 April 2012. The Regulations apply to payments made to members and co-opted members of local authorities, national park authorities and Welsh fire and rescue authorities.

# **INFORMATION**

- For 2022/23 the Panel has decided to make a modest increase in the basic salary for elected members of principal councils, with consequential increases for members of national park and fire and rescue authorities.
- 7 For fire and rescue authorities the Panel's determinations are as follows:

- 8 In addition to the above:
  - the Panel has determined to include a provision for FRAs to apply for specific or additional senior salaries that do not fall within the current remuneration framework
  - members must not receive more than one FRA senior salary
  - an FRA senior salary is paid inclusive of the FRA basic salary and must reflect significant and sustained responsibility
  - members of a principal council in receipt of a band 1 or band 2 senior salary cannot receive a salary from any FRA to which they have been nominated. Where this situation applies, it is the responsibility of the individual member to comply.

The Chair of the North Wales Fire and Rescue Authority is also the Chair of the Executive Panel and can only claim one salary. In order to differentiate between 'main committee' and 'other committee', it is recommended that it is based on the number of meetings held per year. The Executive Panel meets five times per year and the Audit Committee meets 3 times per year. Therefore, it is recommended that the Authority continues with its previous decision that the Chair of the Audit Committee will be paid under the category "other committee chair".

# **Independent Members**

The fee paid to independent members of the Standards Committee has remained the same. The daily fee is capped at a maximum of 4 full days per year on the following rates:

# Travel, Subsistence and Care Allowance

There have been no changes to travel, subsistence and care allowances which are in line with Welsh Government rates. Members are reminded that it was agreed at the NWFRA meeting in June 2018 that subsistence can be claimed when members are away from home for five hours or more, this is in line with the HMRC rules.

#### • Subsistence

£28 per day Day allowance for meals, including breakfast,

where not provided in the overnight charge. Must be away for five hours or more to claim

subsistence.

#### Accommodation

£200 per night London

£95 per night Elsewhere

£30 per night Staying with friends and/or family

Mileage rate remains at 45p per mile.

- Members are also reminded that to support current members and to encourage diversity, the IRPW has urged authorities to promote and encourage greater take-up of the reimbursement of costs of care. All authorities must provide for the reimbursement of necessary costs for the care of dependent children and adults (provided by informal or formal carers) and for personal assistance needs up to a maximum of £403 per month. Reimbursement must be for the additional costs incurred by members in order for them to carry out their approved duties. Reimbursement shall only be made on production of receipts from the carer.
- 13 The Panel's determination in relation to care and personal assistance states:

"All relevant authorities must provide a payment towards necessary costs for the care of dependent children and adults (provided by informal or formal carers) and for personal assistance needs as follows:

Formal (registered with Care Inspectorate Wales) care costs to be paid as evidenced.

Informal (unregistered) care costs to be paid up to a maximum rate equivalent to the Real UK Living Wage at the time the costs are incurred.

This must be for the additional costs incurred by members to enable them to carry out official business or approved duties. Each authority must ensure that any payments made are appropriately linked to official business or approved duty. Payment shall only be made on production of receipts from the care provider."
